INFORMAL TRANSCRIPT OF A CALL RECEIVED, IN ENGLISH, BY RTL-TV1 (RADIO-TV LUXEMBOURG) OFFICE IN BRUSSELS, ON WEDNESDAY, APRIL 19, 1995 AT 1745-1800, CLAIMING RESPONSIBILITY FOR THE FEDERAL BUILDING IN OKLAHOMA CITY. (BEGIN INFORMAL TRANSCRIPT):

STATION REP: HELLO?

CALLER: YEAH, THIS IS MOHAMMED AL-HALI (PHONETIC) HERE: . . .

CALLER: IT MIGHT HAVE LINK...IN FACT, SOME GUYS OF WACO BUT IT'S NOT ACTUALLY ABOUT WACO, TEXAS. THE STUFF WITH DAVID KORESH IN WACO TEXAS HAS GOT NOTHING TO DO WITH IT.

STATION REP: AND WHO ARE YOU? WHY DID YOU DO THAT?

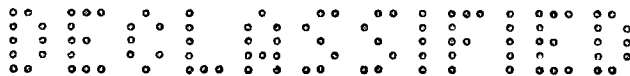

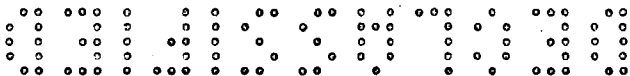
