This is to inform you that our Chief of Station in [redacted] spoke at mid-day on 20 April 1995 with the Chief of the [redacted] about the possibility that [redacted] had prior information about the 19 April 1995 attack in Oklahoma City, Oklahoma. The Chief of [redacted] said categorically that his service had no such prior information about the attack. The Chief [redacted] also said that any information about the Oklahoma City attack developed by his service would be immediately passed to the CIA and the U.S. Government.
