On 4/13/95, SA's [redacted] conducted an interview of ABDUL HAKIM ALI, AKA ABDUL HAKIM ALI HASHEM MURAD. MURAD was interviewed as he was being transported from Manila, Philippines to New York as a result of a sealed indictment issued by the United States Federal District Court for the Southern District of New York. The indictment of MURAD charged him with Title 18 USC Section 32 Conspiracy to Destroy U.S. Civil Aircraft. MURAD was advised of the identities of the interviewing agents and the purpose of the interview. MURAD was read his rights in English and stated that he understood. MURAD then read his advise of rights in both English and Arabic and again stated that he understood. MURAD then signed the waivers of his rights, witnessed by the interviewing agents. MURAD agreed to speak to the interviewing agents and provided the following information in English.
