REASONS 1.5 (B) AND (D).
2. PLEASE THANK AHMAD AL-SHAMSII FOR PROVISIONS OF  
PRELIMINARY LIST OF PROPOSED UAE EQUIPMENT DONATION. WE  
WOULD ALSO BE INTERESTED IN RECEIVING LIST OF ADDITIONAL  
EQUIPMENT THAT WILL BE OFFERED.
3. WE WILL PROVIDE UAE LIST TO MPRI CONTRACTORS IN ORDER  
FOR THEM TO WORK WITH FEDERATION ARMED FORCES AND MOD TO  
ENSURE THAT PROFFERED EQUIPMENT IS APPROPRIATE WITHIN  
PLANNED FEDERATION FORCE STRUCTURE AND TO ENSURE THAT IT  
CAN BE SUPPORTED LOGISTICALLY.
4. TO FACILITATE THESE JUDGMENTS, IT WOULD BE USEFUL TO  
KNOW CONDITION OF PROPOSED ITEMS, WHETHER THEY WILL BE  
PROVIDED WITH SPARE PARTS AND SPECIALTY TOOLS AND WHETHER  
AND FOLLOW-ON AMMUNITION WILL BE PROVIDED. PLEASE  
ALSO SEEK TO ASCERTAIN WHETHER UAE WILL PAY FOR ABU DHABI  
TO BOSNIA SHIPMENT AND ANTICIPATED MODE.
5. NOTE THAT, WITH REGARD TO TRANSPORTATION, SHIPMENT  
SHOULD TAKE PLACE WHEN THE FEDERATION IS CAPABLE OF  
RECEIVING AND SAFEGUARDING SUPPLIES. UAE OFFICIALS SHOULD  
ALSO BEAR IN MIND THAT BOSNIAN FEDERATION, UNDER IFOR  
REGULATIONS AND CSBM AGREEMENT, IS REQUIRED TO PROVIDE  
CERTAIN ADVANCE NOTIFICATIONS FOR ANY MILITARY EQUIPMENT
