1. SUMMARY: [REDACTED] ACTING J-6, JTF/SWA, INFORMED THE EMBASSY THAT A FEMALE HAD CALLED HIS OFFICE AT 1200 HOURS LOCAL AND CLAIMED RESPONSIBILITY FOR THE OKLAHOMA CITY BOMBING. FROM COMMENTS, CALLER SEEMED TO BE A CRANK. END SUMMARY

2. [REDACTED] ACTING J-6, JTF/SWA, INFORMED THE EMBASSY THAT HE HAD RECEIVED A CALL AT 1200 HOURS LOCAL FROM A FEMALE CALLER. THE CALLER SAID THAT SHE HAD BEEN BRAIN-WASHED BY THE FBI AND SHE HAD BLOWN UP THE BUILDING IN OKLAHOMA CITY IN RETALIATION. [REDACTED] TALKED TO THE LADY WHILE ANOTHER JTF/SWA MEMBER IN THE OFFICE TRIED TO INITIATE TRACES ON THE CALL. AFTER CLAIMING RESPONSIBILITY FOR THE BOMBING, THE CALLER INTERROGATED [REDACTED] CONCERNING HIS UNIT, TELEPHONE NUMBER, ETC. [REDACTED] ASKED HER HOW SHE GOT TO OKLAHOMA CITY AND SHE SAID SHE FLEW IN FROM TEXAS (SHE WAS NOT MORE SPECIFIC). IN RESPONSE TO A REQUEST FOR HER PHONE NUMBER SHE SAID 6969 (NOT ENOUGH DIGITS FOR A SAUDI PHONE). WHEN THE CALLER STARTED SAYING HOW NICE THE CAPT'S VOICE SOUNDED AND MAKING NO SENSE, THE CAPTAIN HUNG UP ON HER.

3. THE CALLER CALLED BACK A SECOND TIME AND WANTED TO KNOW WHY HE HAD HUNG UP ON HER. [REDACTED] BLAMED THE PROBLEM ON THE PHONE SYSTEM AND THE WEATHER. THE CAPT AGAIN ASKED FOR HER NAME AND SHE SAID SHE WAS JACKIE IN THE BOX. SHE HUNG UP AS JTF/SWA WAS ATTEMPTING TO CONDUCT A PHONE TRACE.
