MARSHALL [REDACTED] INDICATED THAT THE UNKNOWN PERSON USED  
THE ABOVE NAMES IN CONVERSATIONS WITH PERSONS "AROUND TOWN."  
HIS CAR IS REGISTERED TO [REDACTED] OF BURLINGTON, WI. HE  
PAYS HIS RENT IN CASH, CARRIES A 45 CAL. PISTOL, HAS NO  
VISIBLE MEANS OF SUPPORT, AND HAS BEEN ATTEMPTING TO RECRUIT  
"YOUNG BOYS" INTO THE "BROTHERHOOD."
